RESOLUTION AMENDING RESOLUTION NO. 22-151 S. 2022 OTHERWISE KNOWN AS "RESOLUTION APPROVING THE STANDING COMMITTEES OF THE SANGGUNIANG PANLUNGSOD OF BATANGAS CITY, JURISDICTION, THE CHAIRMANSHIP AND MEMBERSHIP THEREOF"

WHEREAS, the Sangguniang Panlungsod ng Batangas deems that it is necessary that along with the SK President's assumption into office and being an integral part of this Honorable legislative body, it is vital that he be bestowed with Committee Chairmanship and Memberships duly mandated by R.A. 10742 otherwise known as "AN ACT ESTABLISHING REFORMS IN THE SANGGUNIANG KABATAAN CREATING ENABLING MECHANISMS FOR MEANINGFUL YOUTH PARTICIPATION IN NATION-BUILDING AND FOR OTHER PURPOSES";

WHEREAS, Section 22(b)(c) of R.A. 10742 otherwise known as "AN ACT ESTABLISHING REFORMS IN THE SANGGUNIANG KABATAAN CREATING ENABLING MECHANISMS FOR MEANINGFUL YOUTH PARTICIPATION IN NATION-BUILDING AND FOR OTHER PURPOSES" provides that:

- (b) He or she shall be the chairperson of the Committee on Youth and Sports Development in the said Sanggunian, and a regular member of the Committees on Education, Environment, Employment and Livelihood, Health and Anti-Drug Abuse and Gender and Development;
- (c) He or she shall serve as ex-officio member of Local School Board, Local Council for the Protection of Children, Local Development Council, Local Health Board, Local Tourism Council and Local Peace and Order Council.

WHEREAS, Mr. Marcus Manuel D. Castillo was elected SK Chairman of Barangay Bucal on the recent Barangay SK Elections and consequently elected as Sangguniang Kabataan Federation President last November 14, 2023;

WHEREAS, the Sangguniang Panlungsod ng Batangas in session duly assembled hereby amends RESOLUTION NO. 22-151 S. 2022 OTHERWISE KNOWN AS "RESOLUTION APPROVING THE STANDING COMMITTEES OF THE SANGGUNIANG PANLUNGSOD OF BATANGAS CITY, JURISDICTION, THE CHAIRMANSHIP AND MEMBERSHIP THEREOF" providing SK Federation President Marcus Manuel D. - CC. **COMMITTEE ON WAYS AND MEANS** – all matters relating to revenue generally or sources of income for the City Government.
- EE. **COMMITTEE ON EDUCATION** – all matters relating to education including all matters relative to public and private educational institutions.
