A RESOLUTION REQUESTING THE BUSINESS PERMITS AND LICENSING OFFICE THRU THE CITY MAYOR'S OFFICE TO CONDUCT REGULAR-RANDOM INSPECTION TO ALL RESTAURANTS, HOTELS, GROCERIES AND/OR SUPERMARKETS, PHARMACIES, ETC. TO ENSURE THAT THE SENIOR CITIZEN AND PERSONS WITH DISABILITIES (PWDS) ARE GRANTED PRIVILEGES UNDER RA 9994 OTHERWISE KNOWN AS THE "EXPANDED SENIOR CITIZENS ACT OF 2010"

WHEREAS, Republic Act No. 9994 otherwise known as the "Expanded Senior Citizens Act of 2010", recognizes the contribution to nation-building during their prime and to ensure their well-being through certain benefits once they have turned 60 years of age or have retired;

WHEREAS, the law certainly has good intentions but its implementation has been tricky for many beneficiaries;

WHEREAS, commercial establishment cannot tell senior citizens and persons with disabilities (PWDs) that they are not entitled to the twenty percent (20%) discount, just because the products and services are on promotions or on "promos";

WHEREAS, Consumer Act of the Philippines under Article 116 of RA 7394 clearly states, before launching the sale promo campaign that any person or company must first secure permission from the Department of Trade and Industry (DTI);
