RESOLUTION NO. 22-506 S. 2023

APPROVING THE RESOLUTION NO. 1 S. 2023 OF THE LOCAL HEALTH BOARD OF BATANGAS CITY ENTITLED: "A RESOLUTION ADOPTING THE CREATION OF 20 RURAL HEALTH UNITS IN BATANGAS CITY"

WHEREAS, Republic Act 7160 or the Local Government Code mandates all barangays to have at least one Barangay Health Station;

WHEREAS, the Philippine Health Facility and Development Plan 2020-2040 estimates the health facility requirements for Universal Health Care using a needs-based approach;

WHEREAS, the Health Facility Enhancement Program target ratio for Primary Care Facilities (PCF), i.e. Rural Health Units or Health Center (HC) is one PCF per 20,000 populations;

WHEREAS, primary cares refers to initial contact, accessible, continuous, comprehensive and coordinated care that is accessible at the time of need including a range of services for all presenting conditions, and the ability to coordinate referrals to other health care providers in the health care delivery system, when necessary;

WHEREAS, primary health care refers to a whole-of-society approach that aims to ensure the highest possible level of health and well-being through equitable delivery of quality services;
