**RESOLUTION NO. 22-510 S. 2023**

**A RESOLUTION AUTHORIZING THE CITY MAYOR BEVERLEY ROSE A.  
DIMACUHA TO GRANT SERVICE RECOGNITION INCENTIVE (SRI) FOR THE  
FISCAL YEAR 2023 TO PERMANENT EMPLOYEES OF THE CITY GOVERNMENT  
OF BATANGAS**

**WHEREAS**, His Excellency President Ferdinand “Bongbong” R. Marcos, Jr. issued Administrative Order No. 12 authorizing the grant of Service Recognition Incentive (SRI) to Government Employees for Fiscal Year 2023 in the amount not exceeding Twenty Thousand Pesos (Php 20,000.00);

**WHEREAS**, AO No. 12 states that the Administration recognizes all government employees for their collective and invaluable contribution to the government’s continuing efforts in pursuing the objectives, commitments, targets, and deliverables under the Philippine Development Plan 2023-2028 and the President’s 8-Point Socioeconomic Agenda;

**WHEREAS**, Section 2 of AO No. 12 cites the conditions of the grant of the SRI:

<b>Length of Service</b>	<b>Percentage of Incentive</b>
3 months but less than 4 months	40%
2 months but less than 3 months	30%
1 month but less than 2 months	20%
Less than 1 month	10%

**A RESOLUTION AUTHORIZING THE CITY MAYOR BEVERLEY ROSE A. DIMACUHA TO GRANT SERVICE RECOGNITION INCENTIVE (SRI) FOR THE FISCAL YEAR 2023 TO PERMANENT EMPLOYEES OF THE CITY GOVERNMENT OF BATANGAS**

**WHEREAS**, Section 6 of AO No. 12 enjoins Local Government Units (LGUs) to adopt in their respective offices the grant of SRI to government employees, depending on the LGU's financial capability, subject to the PS limitation in LGU budgets under R.A. No. 7160, and the conditions set forth in Section 2 hereof, at a uniform rate not exceeding Twenty Thousand Pesos (Php 20,000.00), chargeable against the local government fund FY 2023;

**WHEREAS**, the City Mayor, through the City Budget Officer, certifies the availability of fund for the SRI to Batangas City Government Employees;


**WHEREAS**, there is a need to authorize the City Mayor to grant SRI to Batangas City Government Employees for FY 2023;

**NOW THEREFORE**, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to **AUTHORIZE** City Mayor Beverley Rose A. Dimacuha to grant Service Recognition Incentive (SRI) to Batangas City Government Employees, subject to the conditions set forth in AO No. 12, Local Government Code of 1991, and all pertinent accounting and auditing rules and regulations.
