RESOLUTION NO. 22-511 S. 2023

**A RESOLUTION AUTHORIZING THE CITY MAYOR BEVERLEY ROSE A.
DIMACUHA TO GRANT GRATUITY PAY FOR THE FISCAL YEAR 2023 TO
CONTRACT OF SERVICE AND JOB ORDER WORKERS OF THE CITY
GOVERNMENT OF BATANGAS**

WHEREAS, His Excellency President Ferdinand “Bongbong” R. Marcos, Jr. issued Administrative Order No. 13 authorizing the grant of Gratuity Pay to Contract of Service (COS) and Job Order (JO) workers in Government for Fiscal Year 2023 in the amount not exceeding Five Thousand Pesos (Php 5,000.00);

WHEREAS, AO No. 13 states that various agencies are engaging the services of individual workers under Contract of Service (COS) and Job Order (JO) schemes to support the implementation of their respective programs, activities, and projects (P/A/Ps), especially the priority items under the Philippine Development Plan 2023-2028 and the President’s 8-point Socio-economic Agenda;

WHEREAS, stipulated in AO No. 13 is that the grant of the year-end Gratuity Pay to COS and JO workers is a well-deserved recognition of their hard work and valuable participation in the implementation of various P/A/Ps of the government, and pivotal role in the delivery of government services amidst the present socio-economic challenges;

A RESOLUTION AUTHORIZING THE CITY MAYOR BEVERLEY ROSE A. DIMACUHA TO GRANT GRATUITY PAY FOR THE FISCAL YEAR 2023 TO CONTRACT OF SERVICE AND JOB ORDER WORKERS OF THE CITY GOVERNMENT OF BATANGAS

WHEREAS, Section 1 of AO No. 13 are the guidelines of the grant of Gratuity Pay:

Length of Service	Amount of Gratuity Pay
3 months but less than 4 months	Not exceeding Php 4,000.00
2 months but less than 3 months	Not exceeding Php 3,000.00
Less than 2 months	Not exceeding Php 2,000.00

WHEREAS, Section 5 of AO No. 13 enjoins Local Government Units (LGUs) to adopt in their respective offices the grant of Gratuity Pay to workers whose services are engaged through COS and JO, utilizing appropriate and available funding sources, and that corresponding supplemental budget shall be enacted by the respective Sanggunian within FY 2023;

WHEREAS, the City Mayor, through the City Budget Officer, certifies the availability of fund for the Gratuity Pay to Batangas City Government Contract of Service and Job Order workers;


WHEREAS, there is a need to authorize the City Mayor to grant Gratuity Pay to Batangas City Government Contract of Service and Job Order workers for FY 2023;

NOW THEREFORE, be it resolved as it is hereby resolved by the Sangguniang Panlungsod in session assembled, to AUTHORIZE City Mayor Beverley Rose A. Dimacuha to grant Gratuity Pay to Batangas City Government Contract of Service and Job Order workers, subject to the conditions set forth in AO No. 13, Local Government Code of 1991, and all pertinent accounting and auditing rules and regulations.
