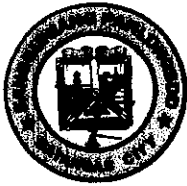

FINDINGS:

The Chairman of the Committee on Appropriations, the members of the Committee, and Members of the Sangguniang Panlungsod briefly made an overview of the subject and stated the following:

1. The Sangguniang Barangays and SK Councils discussed all their respective Annual Budget 2024;
2. The annual budget hearing of the Sangguniang Barangays and SK Councils seek to know if their respective budgets are anchored to Article 2 Section 329-332 of the Local Government Code;
3. The members of the Local Finance Committee stated that the SK Council's projects must be integrated to the Philippine Youth Development Plan and must adopt the Sustainable Development Goals (SDGs);
4. The Sangguniang Panlungsod fully supported all the Sangguniang Barangays and SK Councils in terms of budget-making and is open to all inquiries regarding budget policies and budget-making processes.
5. The Sangguniang Panlungsod reminded that the basis of the budget-making is Section 305 Par. G of the Local Government Code of 1991.
6. Barangays and SK Councils shall exercise taxing power, but shall draft a tax ordinance and conduct a public hearing as stated in Section 186 of the Local Government Code of 1991.

RECOMMENDATIONS:

1. Adoption of this Committee Report; and
2. Approval of the Resolution hereto attached.
